POST SUMMARY MINUTES

PRESENT: Chairman Jeffrey E. Turner, Vice-Chairman Gail Hambrick, Commissioner Sonna Gregory, Commissioner Michael Edmondson, Commissioner Shana M. Rooks, and Clerk Sandra T. Davis.

1. Chairman Turner called the meeting to order.
2. Invocation given by Pastor Dwain Matthews of New Testament Gospel Church of Rex, Georgia. The Pledge of Allegiance to the flag was led by Chairman Turner. A moment of silence was observed for the passing of Commissioner Post Coston of Fayette County, Georgia.
3. Amended the agenda by removing Item No. 25 (Resolution 2015-181 - A Resolution authorizing Clayton County to enter into a Professional Services Agreement with the Carl Vinson Institute of Government, providing for the terms and conditions under which consulting services will be rendered to the County for long term strategic planning.) Vote unanimous. Removed Item No. 30 (Resolution 2015-186 - A Resolution authorizing the Tax Commissioner of Clayton County to conduct Judicial In Rem Foreclosures of Tax Executions.) Vote unanimous. Added Resolution 2015-187- A Resolution authorizing Clayton County to amend an existing contract with Dr. Elizabeth Perry providing for the terms and conditions under which services will be provided to the Clayton County Police Department's Animal Control Division. Vote unanimous. Added Resolution 2015-188 – A Resolution to approve a Memorandum of Understanding to allow Commissioner Sonna Singleton-Gregory to partner with the Castellini Company and American Community Trust to host a job fair, back to school and community outreach event at the Carl Rhodenizer Recreation Center. Vote unanimous. Motion by Commissioner Rooks, second by Commissioner Edmondson, to approve the agenda as amended. Vote unanimous.
4. Approved the June 16, 2015 Regular Business Meeting minutes and June 29, 2015 Special Called Meeting minutes. Vote unanimous.
5. PUBLIC COMMENT: Citizens will be given a three (3)-minute maximum time limit to speak before the Board of Commissioners about various topics, issues, and concerns. Following thirty minutes of hearing from the public, the Board of Commissioners will allow the remainder of citizens who have signed up to be heard at the next Tuesday business meeting.

1. Carl Swinson, member of the Clayton County Citizens Oversight Committee, spoke about the Clayton County Government Finance Corporation. He stated that the purpose of the corporation is to do business with Clayton County. Mr. Swinson stated that the business between the corporation and Clayton County is a conflict of interest. He stated that there was another corporation run out of Clayton County by the name of PHCC, which is handling the work of the development authority, which is also incorporated. Another business that was found, named Clayton County Services Authority, named Chairman Turner as the Chairman of the business. Mr. Swinson stated that he is unsure as to where the funds are coming from to operate the businesses. He also stated that he is unsure as to what the purpose is for having all of the corporations.
2. Heather Middendorf, member of the Clayton County Citizens Oversight Committee, declined to speak.
3. Gail Brawn declined to speak.
4. Tom Huynh, a Clayton County resident, questioned the Board as to why Police Chief Greg Porter was demoted. Chairman Turner explained that Chief Porter was not demoted; he was transferred into a position that would be for the betterment of Clayton County.
5. Elon Rodney declined to speak.
6. Jeffery Benoit, a Clayton County resident, stated that the last meeting held on last Monday, he heard talk of transparency. He referred back to the November 4, 2014 meeting where the Board hired Alex Cohilas for six months, at the rate of \$130,000.00. Never was the position posted that he served in, applications were not received by applicants who were interested in that position, and never was this brought before the Board before Mr. Cohilas was hired. This proves to be a violation of the Sunshine Act to let him know what would happen, and that he was the selected individual without any competition. Mr. Benoit stated that he went to Human Resources to request documentation of those individuals who submitted an application for the position or job announcement, and no information was available. How was that possible, and we are still talking about transparency? He stated that the previous COO was let go, and then the county agreed to pay Mr. Cohilas \$130,000.00 over a six month period. Mr. Benoit questioned if the county paid out over \$230,000.00 in one year to two people. He stated to the Board that the money that is spent is not theirs, it's the taxpayers and the taxpayers would like the same transparency that the Board is asking for.

8. PRESENTATION: "Clayton County Acknowledges Thirteen Student Recipients of the 2015 Scholarship Program of the Kids Outdoor Initiative". (Presented by Interim Chief Operating Officer- Mr. Detrick Stanford)

Mr. Stanford advised that the participants in the program had to submit a 250 word essay describing the outdoor activity that they most wanted to participate in as outlined in the Outdoor Bill of Rights. The trip awarded is courtesy of the scholarship provided as posted during the Lake Spivey Road Race and the Clayton County Barbeque competition that was held. The recipients are: Aaron Blanchard, Allen Chavez, Charlie Cooper, Jayla Freeman, Kyla Guilluame, Robert House, Katie Johnson, Darian Long, Marcus Moses and Nadiyah Timmons. Recipients not in attendance: Moriah Milner, George Popoola, and Jessica Riad.

9. PRESENTATION: "MARTA Update". (Presented by Roberta Abdul-Salaam)

Chairman Turner introduced the new Economic Director, Courtney Pogue, from Chicago, Illinois.

Ms. Roberta Abdul-Salaam thanked the Board for allowing her to present updates to the happenings within MARTA since being elected and appointed to serve on the MARTA Board. She stated that there are two representatives from Clayton County that serve on the MARTA Board and for the benefit of the citizens, just because the members are appointed from Clayton County does not mean that they are only servicing Clayton County, but to know that Clayton County is the first priority. She then introduced the Chief Administrative Officer of MARTA, Mr. Edward Johnson, along with the Planner, Mr. Don Williams, and Yolanda Green. She stated that all of these people are very key individuals, as they are just part of a team who makes the new routes, buses and public hearings happen. The community input that is in place goes to those individuals.

When Clayton County voted to join in with MARTA, it joined the ninth largest transit system in the country. MARTA has a budget of \$400 million yearly; Clayton County is contributing approximately \$29.4 million yearly to that budget. On an average day, MARTA serves over 450,000 riders. She stated that Phase I was implemented on March 21, 2015 and rolled out three routes. Routes 15 and 55 were extended from the Southeast portion of Atlanta and parts of DeKalb County that comes over into

Clayton County. Route 196, the old C-Tran route 501/503, was added; this is the heaviest route in this area. This route has just under 2,000 passengers daily.

Commissioner Rooks asked Ms. Abdul-Salaam what is meant by 2,000 riders/passengers. Mr. Johnson replied that Route 196 originates from the College Park station coming into Clayton County, and there are over 2,000 passenger trips that are generated from that particular route. Commissioner Edmondson questioned as to what is meant by trips. Mr. Johnson clarified that it should be understood as passengers boarding daily. Ms. Abdul-Salaam outlined as to where this route runs. This route runs every 30 minutes during the weekdays and on Saturdays and every 40 minutes on Sundays. This route is only half of Riverdale Road. She explained that MARTA gets a lot of feedback on this route as it pertains to rush hour traffic between the hours of 4:30 p.m. through 6:00 p.m. as it seems to be standing room only on the bus at this time every day. She explained that Route 55 ran down Jonesboro Road and Hutchins Road. This route runs every 20 minutes through the week, every 30 minutes on Saturday and every 45 minutes on Sunday. Ridership has increased on this route; 299 during the week days, 224 on Saturdays, and 157 on Sundays.

Ms. Abdul-Salaam stated that the mobility service is different from the regular bus service. The mobility shuttles are the short buses that we see and they are used for the disabled and elderly community. This service goes door-to-door and picks up the commuters to and from their destinations. To utilize this service there are qualifications that must be met, and there have been workshops held and have others planned for this community to advise on how to apply for the service, and how to call and schedule appointments when they need that mobility service. Currently, only the routes that are being ran qualifies, due to federal law requiring that services be held within three-fourths of an existing route in order to use the mobility service. Ms. Abdul-Salaam stated that as the routes increase, so will the mobility service.

Ms. Abdul-Salaam stated that three new routes are slated to roll out on August 8, 2015. The most exciting for many will be that there is a flex-route service in Lovejoy, Georgia that will connect from the Jonesboro Justice Center. Route 191, will go the full length of Riverdale Road and the airport, via Flint River Road, and will add the much requested service along Highway 138. Service will also be extended along Upper Riverdale Road, along Old Dixie Highway, and will be adding C.W. Grant Parkway. This route will go directly to Hartsfield International Airport, as previously it was only going to the College Park Station. The flex route will run from 5:00 a.m. through 10:00 p.m. during the week days, 9:00 a.m. to 6:30 p.m. on Saturdays, and no service on Sunday as of now. As the need is demonstrated, any part of this schedule is slated to change.

Ms. Abdul-Salaam also shared that there is a great need for service along Battlecreek Road, seeing as though that is where the Department of Family and Children Services is located, as well as the Health Department, and Aging Services. This area will be serviced by Route 193. Also, the area where the

new Porsche facility is located will be added to this route. She stated that Forest Park will be getting an additional route, as well as the Phoenix Boulevard area being covered and going over onto Godby Road and running down Old National Highway to Highway 138.

Mr. Johnson explained and reviewed the ridership chart with the Board. This information provided is for Routes 15 and Route 55 in the Clayton County area only. He stated that with the additional services that will be added in August, more people will be driven to utilize those routes.

Ms. Abdul-Salaam noted that MARTA and Clayton County jointly have held a total of 11 job fairs, and have had at least 3,000 attendees for the job fairs. There have been 136 new hires, and 45 individuals have been from Clayton County. She stated that there has been a tremendous amount of news coverage, as this is something new and big. This has been the biggest thing that MARTA has done in the last 45 years; this is the first time that Clayton County has ever done this. She commended the County Commission and MARTA for making such a huge decision for the citizens of Clayton County within such a short period of time. Ms. Abdul-Salaam stated that this is great, seeing as though no money has been exchanged as of yet.

The last point that Ms. Abdul-Salaam covered is that of safety and security. She stated that this is top priority for MARTA and wanted to make the community aware that she was not being bias, as she does not work for MARTA. She stated that for Clayton County, there have been two vehicle accidents involving MARTA vehicles since service started March 21, 2015; one was a side swipe that happened in Riverdale, Georgia, with minimal damage and no injuries. The other incident, which also happened in Riverdale, Georgia, occurred when a citizen “cut off” a MARTA bus and there were minor passenger injuries. In terms of crime, there has not been one criminal incident notated on the system in Clayton County.

There will be a community event in Lovejoy on August 7, 2015, and new routes will begin on August 8, 2015. There will also be a documentary shown where some of the locals will be featured. This was captured by Tyler Perry Studios, as they donated their time to capture this.

Vice-Chairman Hambrick questioned if the \$29.4 million included what MARTA was “holding”. Ms. Abdul-Salaam advised that this amount is what has been calculated into the MARTA budget for this year for Clayton County, and does not include any of the escrow.

Vice-Chairman Hambrick stated that she has received several letters from constituents about trash at the MARTA bus stops. She stated that she has seen in Fulton County where there is MARTA trucks picking up trash, and questioned if Clayton County would receive the same type service. Ms. Abdul-Salaam explained that MARTA is contracted with a company called Outdoor Advertising. Within the contract between the two, Outdoor Advertising is contracted to service all of the shelters that they have put up and put out. They, not MARTA, service and maintain those sites. She stated that as of now,

Clayton County is not included in that contract; however, there are current negotiations and conversations taking place which will determine whether or not Clayton County will be added onto the contract. Clayton County will also be given the opportunity to seek its own advertiser, to be able to make its own agreements and arrangements. She stated that the trash that Vice-Chairman Hambrick is referring to is along a walking path that has been in the area for years, and is not something that has just occurred. The issue is to determine what jurisdiction this is in, so that the cleanup can be completed.

Commissioner Gregory questioned if MARTA could assist with getting some shelters, seeing as though the riders have to stand out in the unbearable weather conditions while they wait for the service. She stated that she has also received emails in regards to the buses parking in the no parking areas within the neighborhoods, and ask for help from MARTA in maintaining the communities. Commissioner Gregory stated that she has had to call this information in to customer service, and at times has had to escalate the call. Mr. Williams encouraged the calls stating that if they are not aware, then MARTA does not know what needs to be addressed. Commissioner Gregory expressed that help is needed, especially when the citizens contact customer service and there is no response. Ms. Abdul-Salaam expressed that if there is a true issue, she and other members of the MARTA Board try and address it as effectively as possible.

Chairman Turner stated that if the frequency along Route 196 was to be expanded, he felt that the service would really “explode” up and down Riverdale Road and this would be great for the citizens in Clayton County.

Commissioner Edmondson questioned if the McCart Group was the same company that the county chose not to renew a contract with earlier this year except for the window needed to transfer the health

records over. Renee Bright, Human Resources Director, advised that it was a different company by the name of the Alexander Company. Commissioner Edmondson also questioned as to why an entire year is needed to revise the scope of service to put this back out. Ms. Brewer advised that the county is reviewing all of the RFP's, including the scope and the terms, to ensure that the county is receiving the best benefits that it can. Commissioner Edmondson questioned why have the contract for a year; is it going to take that long to determine if there are some efficiencies and benefits to put it back out or change it. Ms. Brewer replied that there may be; in some of the policies that they are providing broker services, however, she does not have an exact date, and it's just not for one policy.
