RESOLUTION NO. 2011 - 208

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW WOODBRIDGE PRODUCTIONS, INC. TO ENTER UPON, USE AND BY MEANS OF FILM, TAPE OR ANY OTHER METHOD TO PHOTOGRAPH THE PROPERTY, INCLUDING INTERIORS AND EXTERIORS OF ALL BUILDINGS, IMPROVEMENTS AND STRUCTURES THEREON AND THE CONTENT THEREOF LOCATED AT THE CLAYTON COUNTY JUVENILE JUSTICE COMPLEX NOW UNDER CONSTRUCTION AND TO PARK VEHICLES, TRUCKS AND EQUIPMENT IN THE PARKING AREA SURROUNDING THE COURHOUSE; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Woodbridge Productions, Inc. is filming a movie in the Clayton County area, and has determined that the Clayton County Juvenile Justice Center now under construction is a location that would be desirable for filming a scene for the movie; and

WHEREAS, the Clayton County through the Clayton County Economic Development Office desires to enhance the development of the movie and film industry within Clayton county; and

WHEREAS, there will be no cost to the county, and Woodbridge Productions, Inc. has agreed to indemnify and hold Clayton County harmless from all liability for injury or damages during the filming; and

WHEREAS, the filming will take place at a time that will not conflict with the operation of the offices located at the courthouse and the use of the parking area and the facility under construction has been approved by the Sheriff of Clayton County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing Woodbridge Productions, Inc. to utilize the Juvenile Justice Construction site for this purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners authorizes Clayton County to allow Woodbridge Productions, Inc. to use the parking lot around the Clayton County Judicial Building for the parking of vehicles and the storage of equipment and the Clayton County Juvenile Justice Center construction site for the to enter, use and by means of film, tape or any other method to photograph the property, including interiors and exteriors of all buildings, improvements and structures thereon and the content thereof .

Section 2. The Board of Commissioners authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution.


Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


