RESOLUTION NO. 2014-147

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST TO THE NAACP ACT-SO TO HOST A FUNDRAISER AT THE SOUTH CLAYTON RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request NAACP ACT-SO (the "Request") for use of the Community Room at the South Clayton Recreation Center (the "Center") for the purpose of hosting a fundraiser to cover the cost for student Gold Medal winners to attend the national competition; and

WHEREAS, the event will be held on Friday, June 27, 2014 from 6:00 p.m. to 9:00 p.m.;
and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Special Facility Use request for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request for the NAACP ACT-SO to host a fundraiser at the South Clayton Recreation Center. The Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of this resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
