RESOLUTION NO. 2015-132

A RESOLUTION AUTHORIZING CLAYTON COUNTY FIRE AND EMERGENCY SERVICES TO ENGAGE IN FUNDRAISING EFFORTS AND TO SOLICIT AND ACCEPT DONATIONS FOR COMMEMORATIVE BRICKS IN THE MULTI-PURPOSE TRAINING FACILITY; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET AS NEEDED TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County (the "County") Fire and Emergency Services (the "Department") wishes to engage in fundraising activities by requesting and accepting donations for commemorative bricks (the "Fundraiser") to be placed in or near the new Multi-Purpose Training Facility; and;

WHEREAS, all funds raised during the Fundraiser will be utilized for fire training purposes; and

WHEREAS, the Fundraiser will have no financial impact to the County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by authorizing the Department to conduct the Fundraiser.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County Fire and Emergency Services to engage in fundraising efforts and to solicit and to accept donations for commemorative bricks to be installed in or near the new Multi-Purpose Training facility. The Board of Commissioners authorizes the Chairman to perform all other acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget as needed to reflect an appropriate revenue source and expense.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.


