RESOLUTION NO. 2015-147

A RESOLUTION TO APPROVE A PROPERTY USE REQUEST TO ALLOW CLUB XHELL, INC, DBA CLUB XHELL YOUTH LIFE CENTER TO USE VACANT COUNTY OWNED PROPERTY LOCATED AT 200 VALLEY HILL ROAD FOR CHILDREN'S RECREATIONAL OUTDOOR ACTIVITES; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, representatives of Club Xhell, Inc., DBA Club Xhell Youth Life Center, a non-profit day care facility located in Clayton County, Georgia (the "Host"), wish to utilize vacant Clayton County owned property located at 200 Valley Hill Road in Riverdale, Georgia (the "Location") to allow for children's outdoor recreational activity from June 1, 2015 until August 8, 2015; and

WHEREAS, the County will waive any property use fees; and

WHEREAS, Clayton County deems it in the best interest of the County and the County will best be served by allowing the Host to utilize for these purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby agrees to allow Club Xhell, Inc. DBA Club Xhell Youth Life Center to utilize County property located at 200 Valley Hill Road in Riverdale, Georgia for children's outdoor recreation activities from June 1, 2015 until August 8, 2015. The Board authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves a waiver of any property use fees.


