RESOLUTION NO. 2015-157

A RESOLUTION TO APPROVE A SPECIAL FACILITY USE REQUEST TO ALLOW ALPHA OUTREACH, INC. USE OF MEETING SPACE AT THE CARL RHODENIZER RECREATION CENTER IN EXCHANGE FOR MEMBERS OF THE PI GAMMA LAMBDA CHAPTER OF ALPHA PHI ALPHA FRATERNITY, INC. PARTICIPATING IN A MENTORING PROGRAM AT THE CARL RHODENIZER RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, representatives of Alpha Outreach, Inc. (“Alpha Outreach”), a non-profit organization formed as a project of the Pi Gamma Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. (the “Chapter”), wishes to utilize the Carl Rhodenizer Recreation Center (the “Location”) to host meetings on the third Tuesday of the month, based on availability, excluding July and August; and

WHEREAS, the meetings will take place from 6:45 p.m. until 9:00 p.m., with no impact on County staff or programming; and

WHEREAS, Alpha Outreach and the Director of the Parks and Recreation Department (the “Department”) are requesting consideration by the Clayton County Board of Commissioners to approve a waiver of the Department’s facility use cost in exchange for members of the Chapter participating in a mentoring program at the Location; and

WHEREAS, Alpha Outreach will be required to make monthly requests to use space at the Location; and

WHEREAS, Alpha Outreach's use of space at the Location will be contingent on the availability of space; and

WHEREAS, Clayton County deems it in the best interest of the County and the County will best be served by allowing Alpha Outreach to hosts its meetings at the Location in exchange for members of the Pi Gamma Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. participating in a mentorship program at the Location.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby agrees to allow Alpha Outreach, Inc., a non-profit organization formed as a project of the Pi Gamma Lambda Chapter of Alpha Phi Alpha Fraternity, Inc., to host its meetings at the Carl Rhodenizer Center on the third Tuesday of the month, excluding July and August, contingent on the availability of space at the time of Alpha Outreach's monthly request.

Section 2. The Board of Commissioners approves a waiver of the Parks and Recreation Department's facility use cost under the condition that members of the Pi Gamma Lambda Chapter of Alpha Phi Alpha Fraternity, Inc. participate in a mentorship program at the Location.

Section 3. The Board authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 4. This Resolution shall be effective immediately upon approval by the Board of Commissioners.




