RESOLUTION NO. 2015-165

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT SUPPLEMENTAL GRANT FUNDS AWARDED BY THE CRIMINAL JUSTICE COORDINATING COUNCIL FOR THE PURPOSE OF FUNDING A JUVENILE COURT OFFICER POSITION; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE GRANT AWARD AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET AS NEEDED TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Juvenile Court previously applied for and was awarded \$409,465 in grant funds from the Juvenile Justice Incentive Grant Program which allowed Juvenile Court to reduce incarcerations of youth; and

WHEREAS, Juvenile Court has now received supplemental grant funds in the amount of \$47,944 which will be used to provide funding for a Juvenile Court Officer (JTS Coordinator) position; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by accepting the supplemental grant funds for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County, on behalf of Clayton County Juvenile Court, to accept supplemental grant funds in the amount of \$47,944 to be used to fund a Juvenile Court Officer (JTS Coordinator) position. The


Board hereby authorizes the Chairman to execute the grant award and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget as needed to reflect an appropriate revenue source and expense, all as may be required.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.




