RESOLUTION NO. 2015 – 188

A RESOLUTION TO APPROVE A MEMORANDUM OF UNDERSTANDING TO ALLOW COMMISSIONER SONNA SINGLETON GREGORY TO PARTNER WITH THE CASTELLINI COMPANY AND AMERICAN COMMUNITY TRUST TO HOST A JOB FAIR, BACK TO SCHOOL AND COMMUNITY OUTREACH EVENT AT THE CARL RHODENIZER RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET AS NEEDED TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Castellini Company and American Community Trust (the “Partners”), in partnership with Commissioner Sonna Singleton Gregory, wishes to host a combination Job Fair/Back to School/Community Outreach Event; and

WHEREAS, the event will be held at the Carl Rhodenizer Recreation Center on August 8, 2015 from 11:00 a.m. until 4:00 p.m. (the “Event”); and

WHEREAS, the County deems it in the best interest of the County by allowing Commissioner Sonna Singleton Gregory and the Partners to host the Event; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF

CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby approves a Memorandum of Understanding to allow Commissioner Sonna Singleton Gregory to partner with the Castellini Company and American Community Trust to host a combination Job Fair/Back to School/Community Outreach Event at the Carl Rhodenizer Recreation Center. The agreement

is attached hereto as "Attachment A". The Board of Commissioners hereby authorizes the Chairman to execute the agreement and to otherwise perform all acts necessary to accomplish the intent of the Resolution. The Board further authorizes the Chief Financial Officer to amend the Budget as needed to reflect an appropriate revenue source and expense all as may be required under the terms of the agreement.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
