RESOLUTION NO. 2015-30

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT TO ALLOW REAL HELP! NETWORK, INC. TO SPONSOR AND HOST A SOUP TASTING COMPETITION AT THE SOUTH CLAYTON RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Real Help! Network, Inc. (the "Promoter") desires to sponsor and host an event entitled, "Souper Saturday," a soup tasting competition on February 21, 2015 from 10:00 a.m. to 3:00 p.m. at the South Clayton Recreation Center; and

WHEREAS, the Promoter will use this event to raise funds to benefit the Clayton County Drug Free Community (DFC) Youth Coalition by requiring a \$5.00 entry fee to the public; and

WHEREAS, the Promoter is requesting complimentary use of the facility, however the Director of the Parks and Recreation Department (the "Department") is requesting approval by the Board of Commissioners of the Department's facility use cost of \$250.00 (which is 50 percent off the total cost of \$500.00 as a 501(c)(3) organization); and

WHEREAS, the Promoter shall have sole responsibility for organizing, promoting and managing the event, with no capital expense to Clayton County; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into a License Agreement with the Promoter to host these events.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement to allow Real Help! Network, Inc. to sponsor and host a soup tasting competition on February 21, 2015 at the South Clayton Recreation Center. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto, subject to any minor changes or deletions that the Board of Commissioner may approve, and otherwise perform all acts necessary to accomplish the intent of this Resolution.




