RESOLUTION NO. 2015 - 303

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO EXECUTE A LICENSE AGREEMENT WITH AMERICAN CANCER SOCIETY, SOUTH ATLANTIC DIVISION, INC., TO HOST A FUNDRAISER WALK AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request (the "Request") from American Cancer Society, South Atlantic Division, Inc. (the "Promoter") for use of the Clayton County International Park (the "Park") for the purpose of hosting a fundraiser walk named "Relay for Life of Clayton County"; and

WHEREAS, the Park space will be utilized on Saturday, April 30, 2016 starting at 10:00 a.m. until Sunday, May 1, 2016 at 1:00 a.m.; and

WHEREAS, the Director of the Parks and Recreation Department recommends that Promoter will pay for the services of one coordinator (\$20 per hour for sixteen hours—\$320.00) and one maintenance employee (\$10 per hour for twenty-four hours—\$240.00) for a total payment to the County of \$560.00; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request and executing a license agreement to use the Park space for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Parks and Recreation Department, to execute a license agreement with American Cancer Society, South Atlantic Division, Inc. to host a fundraiser walk at the Clayton County International Park on Saturday, April 30, 2016, and also authorizes the Chairman to execute the documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 2. American Cancer Society, South Atlantic Division, Inc. will pay for the services of one coordinator (\$20 per hour for sixteen hours—\$360.00) and one maintenance employee (\$10 per hour for twenty-four hours—\$240.00) for a total of \$560.00.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by the Clayton County Risk Management Department.




