RESOLUTION NO. 2015-61

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A PERFORMANCE AGREEMENT WITH FREESTYLE PRODUCTIONS, LLC PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH LIVE ENTERTAINMENT WILL BE PERFORMED AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County and Freestyle Productions, LLC (the "Promoter") wish to enter into a Performance Agreement to provide live entertainment to be performed at Clayton County International Park, "The Beach" during Memorial Day weekend activities on Saturday, May 23, 2015 and during Fourth of July activities on Friday, July 4, 2015 (the "Agreement"); and

WHEREAS, the Promoter will require and cause four bands under the terms and conditions of the Agreement to begin set-up and sound check at 8:00 a.m. on both May 23, 2015 and July 4, 2015, and each band will perform two (2) sessions on its scheduled date between 10:00 a.m. and 8:00 p.m.; and

WHEREAS, Clayton County will pay the Promoter a total fixed rate of \$12,000.00 for both show dates from the account of Clayton County Parks and Recreation Department; and

WHEREAS, the bands' live entertainment will serve as additional entertainment to encourage patrons to choose The Beach as a destination on Memorial Day weekend and the Fourth of July, and funds are available to support these expenses; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into an agreement with the Promoter for the foregoing purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a Performance Agreement with Freestyle Productions, LLC (the "Agreement") to provide live entertainment at Clayton County International Park, "The Beach" during Memorial Day weekend activities on Saturday, May 23, 2015 and during Fourth of July activities on Friday, July 4, 2015.

Section 2. The Board of Commissioners authorizes the Chairman to execute the Agreement attached hereto as Attachment "A" and otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners further authorizes the Chief Financial Officer to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Agreement.






