RESOLUTION NO. 2015-77

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH THE CLAYTON HENRY CHAPTER OF THE NATIONAL ACTION NETWORK, INC. TO HOST A 50 YEAR CELEBRATION OF THE CIVIL RIGHTS MOVEMENT AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, members of the Clayton Henry Chapter of the National Action Network, Inc. (the "Promoter") wish to utilize levels 1 and 2 of the VIP Complex at Clayton County International Park (the "Location") to host a 50 year celebration of the Civil Rights Movement entitled, "Voices of Legions" (the "Event"); and

WHEREAS, the Promoter wishes to utilize the Location on September 12, 2015 from approximately 10:00 A.M. until 10:00 P.M., with the purposes of fundraising for National Action Network, Inc. and celebrating those who labored in the Civil Rights Movement by allowing them to tell their "stories of services without glory", to include music, food and vendors; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's recommended event rental fee for the Event; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host the Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with the Clayton Henry Chapter of the National Action Network, Inc. (the “Promoter”), providing for the terms and conditions under which the Promoter will utilize levels 1 and 2 of the VIP Complex at Clayton County International Park on September 12, 2015 to host a 50 year celebration of the Civil Rights Movement entitled, “Voices of Legions” (the “Event”). The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment “A” and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the Parks and Recreation Department’s recommended fee as outlined in the License Agreement, to be paid by the Promoter for the Event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the event date as provided by the Clayton County Risk Management Department.


