RESOLUTION NO. 2016- 69

A RESOLUTION TO AUTHORIZE CLAYTON COUNTY TO ENTER INTO A LICENSE AGREEMENT WITH GREG STREET PRODUCTIONS, INC. TO HOST A CAR AND BIKE SHOW AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, AS MAY BE REQUIRED UNDER THE TERMS OF THE AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Greg Street Productions, Inc. (the “Promoter”) wishes to utilize the Clayton County International Park (the “Location”) to host a car and bike show entitled, “Bik-Nik Presents: Food Trucks @ the Beach” which will include live music, food vendors, and alcohol vendors; and

WHEREAS, the Promoter wishes to utilize the Location in Jonesboro, Georgia on May 22, 2016, from approximately 2:00 P.M. until 10:00 P.M.; and

WHEREAS, the Director of the Parks and Recreation Department (the “Department”) recommends the following fees: a Special Event Fee of \$700.00, Rental Fees of \$1,900.00, a refundable Deposit Fee of \$300, a Park Coordinator Fee of \$280.00 for organization and safety purposes (at a rate of \$20.00 per hour for 14 hours), an Event Maintenance Staff Fee of \$400.00 (for four employees at \$10.00 per hour for 10 hours), and four County Police Officers for \$1,440.00 (\$45.00 per hour per officer for 8 hours), for a total of \$5,070.00; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host this event for the total fee recommended above by the Department.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with Greg Street Productions, Inc. providing for the terms and conditions under which Clayton County International Park will be utilized to host a car and bike show entitled, the “Bik-Nik Presents: Food Trucks @ the Beach” which will include live music as well as food and alcohol vendors.


Section 2. The Board of Commissioners authorizes the Chairman to execute the License Agreement, a copy of which is attached, and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 3. The Board of Commissioners approves the Parks and Recreation Department’s fee recommendations: a Special Event Fee of \$700.00, Rental Fees of \$1,900.00, a refundable Deposit Fee of \$300, a Park Coordinator Fee of \$280.00 for organization and safety purposes, an Event Maintenance Staff Fee of \$400.00, and four County Police Officers for \$1,440.00, for a total of \$5,070.00;

Section 4. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.




