REPORT FROM THE DIRECTOR OF THE LIBRARY

UNFINISHED BUSINESS

December Holiday:

The Commissioners will set holiday observance at June Board Meeting, as such, the Library Board tabled discussing holiday hours/closures until after Commissioners' Meeting.

NEW BUSINESS

Construction Projects:

College Park Library: Director Lett reported she recently met with the Project Manager to discuss SPOLST funding for the new College Park Library. There will be a public meeting held in the upcoming weeks to

discuss plans for the new library. Director Lett will send board members the date and location when details are finalized

Headquarters Library

Family Place Library construction project will begin this week.

Radio Frequency Identification System Reader (“RFID”), construction to begin soon. Training for new system will begin soon. Once RFID system is installed at Headquarters Library, Jonesboro Library will be the next branch to receive the system.

PINES System (Evergreen Software), Conference will be held in Raleigh, NC. Members of Library Staff will be attending.

National Library Week (April 10-16, 2016):

STEAM (Science, Technology, Engineering, Arts and Mathematics) is this year’s focus. Director Lett reported each branch is hosting projects incorporating STEAM initiatives during this week. There will also be an Open House at all library branches throughout the day and evening on April 13, 2016.

Special Summer Reading Newsletter:

The summer “activities” newsletter will be published prior to school summer break (May 19).

New “Reading” Technology:

Director Lett informed the Board of new devices, (Playaways), patrons can check out at the library. A Playaway is a prerecorded audio player. It is the size of a deck of playing cards and weighs 2 ounces, and can store up to 80 hours of audio recording.

Partnerships:

Clayton State University Initiatives- (“PACE”)

Partnering Academics and Community Engagement (“PACE”). Clayton State students are assisting Clayton County Library System “CCLS” with establishing a Teen Advisory Board and a Collegiate Advisory. This board is designed to assist with getting feedback regarding future programming teens and young adults are most interested in.

Members of PACE also assist with literacy one on one tutoring.

Financial Literacy:

Money Smart week is next week. Director Lett stated she and her staff will provide and/or attend events related to financial literacy. Their initiatives include; Attending Eddie White Academy/Operation Hope “Banking on Our Future,” and focusing on the needs and request of Senior

Citizens within the community. Recently a poll was administered at various senior citizens centers regarding financial topics of most interest to them. The top (3) areas of interest are: Estate Planning, Credit Fraud and Investing.

During the summer and fall, the Library will be hosting the following financial literacy programs: Entrepreneurship, family spending, money camp/reality check for children and teens.

Director Lett advised the Board regarding (2) policies *Unattended Children* and the *Meeting Room Policy*. Members of the Board will review and update/revise both policies. The Board will vote on proposed policy changes via electronic mail on Tuesday, April 26, 2016.
